Conditions pertaining to INQUA recognition and funding of and Projects

Please note that, as for all INQUA projects, INQUA recognition and financial support is contingent on the following standing conditions being met:

- a) that funding may be used for:
 - travel, accommodation and (non-alcoholic) subsistence costs of researchers in meetings organised through a Project or Conference. At least 75% of the amount of the grant used to fund participation should support the participation of ECRs and/or DCRs in Project events (see www.inqua.org for definitions);
 - rental of rooms or vehicles for conferences, meetings and/or related field trips;
 - costs associated with videoconferencing (if it's not possible using the INQUA accounts), webcasts or podcasts up to a max of 10% of the grant;
 - other costs than the above with explicit (pre)approval by the Executive Committee.
- b) That project funding may not be used for:
 - supporting attendance or activities at the INQUA Congress;
 - payment of salaries;
 - taking of (institutional) overheads;
- c) that an annual report summarising the Project activities during 2024 and, where relevant, providing precise budget details on how the INQUA funds were spent, be submitted by the 31th of January 2025 (see www.inqua.org for report forms). In case of roll-over or continuation requests, an intermediate report must be submitted by September 30th, 2024;
- d) that *all* original, official non-handwritten receipts (incl. boarding passes for flights) are required for all expenses. Any expense not represented by an official receipt will need to be refunded to INQUA;
- e) that INQUA recognition and support be accorded due profile in any publicity and/or product emanating from, or associated with, the project;
- f) that the project's activities be periodically publicised through issues of INQUA's newsletter, Quaternary Perspectives;
- g) that continuing INQUA recognition of projects, whether in receipt of funding support or not, must be reaffirmed on an annual basis by the INQUA Executive Committee, and is contingent upon the submission of an annual report.
- h) any changes to agreed expenditure must receive the prior agreement of the Treasurer.
- i) it is the responsibility of the project leaders to ensure that INQUA regulations are adhered to regarding the eligibility of expenses. If you have any questions, don't hesitate to contact INQUA Secretary General and/or the INQUA Treasurer.
- j) We are taking this opportunity to remind project leaders of INQUA's guidelines for the use of INQUA funds notably to encourage the participation of scientists from countries with low GDP and the involvement of early career scientists (i.e. scientists with less than 8 years post-PhD experience) in the project's activities and organisation.
